#### What is the Program Area?

Housing Rehabilitation Assistance is available within the boundaries of the Village of Talmage.

### Is a Rental House Eligible?


No; only owner-occupied single-family housing units are eligible.

## What is the typical amount of grant or loan assistance?

Assistance typically ranges from \$15,000 and not to exceed \$25,000 per unit. This limit may exclude a specific home from participating in the program. For example, if it is estimated that a home will still not meet basic standards after \$25,000 in repairs are made, then the home will not be eligible for the program.

### Will I have to pay this back?

The funds are provided as a \$0 payment, 0% interest conditional grant non-repayable as long as the assisted owner does not move, rent, sell, transfer or not occupy the property during the 5-year conditional grant period.



# Owner Occupied Housing Rehab. What repairs are ELIGIBLE?

- ~ Structural-Foundation, Roof, etc.
- Mechanical-Furnace, Water Heater, etc.
- ~ Electrical-Wiring, fuse boxes
- ~ Plumbing
- Weatherization-Windows, Doors,
   Insulation, Siding, etc.
- General Maintenance-Kitchens, Bathrooms, etc.
- Handicapped Accessibility-Ramps, Bathroom, etc.
- ~ Relieve overcrowding
- ~ Safety and Code Deficiencies.

### What is usually not eligible?

- ~ Garages & Outbuildings
- ~ Driveways & Sidewalks
- ~ Window Air Conditioning Units
- ~ Fireplaces
- ~ Patios
- ~ Landscaping & Fences
- ~ Jacuzzis, hot tubs and spas
- ~ Kitchen Appliances
- Any costs for repairs not completed in the program.

### What Financing options will be available?

The financial assistance is provided in the form of a 5-Year "Conditional Grant." If the assisted owner moves, rents, sells, transfers, or does not occupy the property prior to the end of the 5-Year (60 month) lien period, then the owner shall reimburse the program either the full amount granted OR "net proceeds" (sale price of property minus closing costs and minus any repayment of prior liens on the property) if property is sold.


