SOUTHEAST NEBRASKA DEVELOPMENT DISTRICT BOARD OF DIRECTORS MINUTES OF THE JANUARY 24, 2024 MEETING

The January 2024 meeting of the Executive Committee of the Southeast Nebraska Development District (SENDD) was held at SENDD's Lincoln office located at 7407 O Street, Lincoln, NE.

I. CALL TO ORDER

SENDD Chair Erich Tiemann called the meeting to order at 12:07 PM. Pursuant to Section 84-1412(8) of the Nebraska Open Meetings Act, a current copy of the Open Meetings Act was posted in the office foyer and was available for viewing by the public. The SENDD Executive Committee reserves the right to go into executive session in accordance with Section 84-1410.

Roll was taken with a roll call. Quorum was present.

Chair Tiemann presided over the meeting.

Others present were Tom Bliss, Amanda Stutzman, and Kelly Gentrup (virtually) from SENDD. Michele Kelley and Krystal Siebrandt from HBE, LLP attended virtually.

II. ADOPT AGENDA

Chair Tiemann presented the January 24, 2024 agenda. Zabrocki moved to approve the agenda as presented, seconded by Pohlmann. Motion carried unanimously.

III. APPROVAL OF MINUTES

Minutes from the December 7, 2023 SENDD Board of Directors and January 4, 2024 SENDD Executive Committee meetings were distributed prior to the meeting. Chair Tiemann called for a motion. Moved by Mauk to approve both the December 7, 2023 and January 4, 2024 minutes as presented, seconded by Zulkoski. Motion carried unanimously.

IV. TREASURER'S REPORT

Treasurer Mauk introduced Kelley and Siebrandt from HBE, LLP. Mauk continued by presenting SENDD's financial statements ending December 2023. Kelley presented SENDD's Statement of Financial Position ending December 2023. Stutzman offered additional information. The statements were distributed prior to the meeting. Discussion occurred. Chair Tiemann called for a motion. Moved by Zabrocki to approve the December 2024 financial statements as presented, seconded by Zulkoski. Motion carried unanimously.

With Siebrandt and Kelley from HBE attending virtually, Chairman Tiemann moved IV. New Business, Action Item #1 up the agenda, so they could present. The proposal is a continuation of HBE's accounting assistance. No action item was distributed prior to the meeting. Siebrandt provided an overview of the proposal. Discussion occurred. No action taken; however the Executive Committee requested that Stutzman negotiate with HBE on costs.

VII. COMMITTEE REPORTS

- 1. <u>Personnel Committee Report:</u> The committee did not meet. Bliss reported that the Affordable Connectivity Program (ACP) grant was ending prematurely and both Broadband staff had resigned. Due to the questions on funding, SENDD may restructure existing staff duties and avoid recruiting. No action taken.
- 2. <u>Budget and Finance Committee Report:</u> The committee did not meet. No action taken.

VIII. NEW BUSINESS

- 1. Action Item HBE Proposal: See previous minutes.
- 2. Action Item Permission to enter into a grant management contract with the Southeast Nebraska Affordable Housing Council (SENAHC) for its recent Pandemic Housing award not to exceed \$100,000: Bliss presented the action item. Information was distributed prior to the meeting. Discussion occurred. Chair Tiemann called for a motion. Moved by Zulkoski for SENDD to enter into a grant management contract with the SENAHC for its Pandemic Housing program not to exceed \$100,000, seconded by Mauk. Motion carried unanimously.
- 3. Action Item Permission to sell SENDD truck and consider purchase of a company-wide vehicle: Bliss presented on the action item. Information was distributed prior to the meeting. Discussion occurred. Chair Tiemann called for a motion. Moved by Pohlmann to approve staff to list the SENDD truck for a minimum of \$5,000, seconded by Zabrocki. Motion carried unanimously. The actual sale of the truck will be tabled for an electronic vote.
