## 1. INTRODUCTION & BACKGROUND

The Southeast Nebraska Development District (SENDD), a regional planning and economic development organization serving Southeast Nebraska, is soliciting proposals from qualified consultants to support the development of a regional planning document focused on water and wastewater infrastructure. This project is part of the 6 Regions, One Nebraska initiative, supported by the Nebraska Department of Economic Development (NDED) and funded through ARPA's State and Local Fiscal Recovery Funds (SLFRF). SENDD received \$200,000 to implement this regional planning effort, and has budgeted \$100,000 for the services described in the RFP.

To date, SENDD has collaborated with the University of Nebraska–Lincoln (UNL) to develop and deploy a comprehensive infrastructure survey tool using Strata Platforms' Lasso system. A graduate research assistant (GRA) is assisting with outreach and early-stage data collection. Survey efforts are currently underway and have been distributed to approximately 60% of the region.

SENDD is seeking a consultant to build on this work—supporting continued data gathering, analysis, and the creation of a regional plan that will guide future infrastructure investment, help communities access funding, and promote workforce development throughout Southeast Nebraska.

#### 2. PROJECT OVERVIEW

The Southeast Nebraska Regional Infrastructure Project seeks to understand and address the challenges facing water and wastewater systems in rural communities. The final regional plan will serve as a resource to:

- Document the current condition and capacity of systems
- Identify gaps, risks, and barriers to system improvement
- Offer localized and regional strategies for investment, collaboration, and shared services
- Strengthen the region's competitiveness for infrastructure funding
- Support workforce development strategies tied to utility operations and system upgrades

This plan must be actionable, data-driven, and developed with rural realities in mind.

#### 3. SCOPE OF SERVICES

The selected consultant will be expected to perform the following tasks in collaboration with SENDD and UNL:

## A. Planning & Coordination

- Review the current infrastructure survey tool and Lasso platform
- Attend kickoff meetings and participate in periodic check-ins with SENDD and regional partners

### B. Data Collection & Analysis

- Assist with continued community outreach and follow-up to complete survey data collection
- Interpret survey responses and perform regional infrastructure analysis
- Identify common system types, age, condition, compliance issues, and anticipated upgrade needs

## C. Regional Plan Development

- Draft a regional infrastructure planning document that:
  - Summarizes findings across the 15-county region
  - Highlights system vulnerabilities and local priorities
  - Outlines recommended improvements and investment strategies
  - o Suggests possible models for shared services or regionalization
  - o Incorporates workforce development needs and partnerships

### D. Engagement & Reporting

- Provide stakeholder engagement strategies and assist with at least one regional input session or presentation
- Submit a final planning document and executive summary suitable for public and stakeholder audiences

Please submit a concise proposal that includes the following sections:

- 2. Firm Qualifications & Experience
  - Relevant planning experience, particularly in water/wastewater infrastructure and rural contexts
  - Experience working with regional organizations, university partners, and/or public sector clients



- 3. Approach & Work Plan
  - Methodology for completing the scope of services
- 4. Timeline and project management strategy
- 5. Staffing Plan
  - Identification of key staff and their qualifications
  - Estimated level of effort per task
- 6. Project Budget
  - Cost proposal with hourly rates and estimated costs by task
- 7. References
  - Contact information for at least two reasonably similar projects completed in the past five years
